15. PRAYERS

Prayers were offered by the Rev'd D. Sawyer.

16. BRISTOL ROAD/CLIFTON ROAD PROBATION HOSTEL HOUSING COMMITTEE - 6 JUNE 1995 - MINUTE 13

Councillor Stephens (Leader of the Council) was permitted by the Mayor to make a statement in which he updated Members on the current position regarding the proposals for the replacement of the Glyndhurst Hostel on Bristol Road.

Councillor Stephens stated that in the light of continuing discussions between the City Council and the Probation Service, the decision had been reached to not proceed any further with the proposals to relocate the Glyndhurst Hostel onto land owned by the City Council at Bristol Road/Clifton Road. As background information to this decision, Councillor Stephens referred to considerable expressions of anxiety and fears among the local residents, particularly in the vicinity of the proposed site for the replacement hostel. He felt that whilst

the Council was happy for the Probation Hostel to be relocated, that under no circumstances was the Council prepared to see it turned at some future date into a bail hostel or to be used as a residential centre for people who would be either charged with, or convicted of, serious sexual or violent offences.

In the light of the views of the public referred to above, Councillor Stephens stated that Members of the Highways and Planning Committee would be aware of an amendment moved by the Vice Chairman of the Housing Committee seeking, through the planning process, to limit the future use of the site by means of a Section 106 Agreement. Further, it had been his intention to move an amendment at the Council meeting that afternoon, further seeking to strengthen the position by a covenant on the land transfer, that would ensure its future use only as a probation hostel. Also, the proposed covenant would exclude any future use as a bail hostel or for use as a residence for people who had convictions for, or charges of, sexual or violent criminal offences.

Councillor Stephens informed the Council that the wording of both the Section 106 Agreement and a suitable covenant had been agreed with the Gloucestershire Probation Service.

However, it had become clear that the Home Office, who would be financing the project, were not willing to accept any such covenant. Accordingly, against that background and in the light of the Council's previously stated position not to proceed with the land transfer unless there was an agreement, the Probation Services had agreed that the project should no longer proceed.

Councillor Stephens indicated that later in the meeting, there would be an amendment proposed to the Minutes of the Housing Committee to reflect the position as outlined above.

17. MAYOR'S ANNOUNCEMENTS

- 2. The Mayor stated that the Mayor of Trier was that day concluding a visit to the City during which much had been achieved in discussions between the Civic leaders.

The Mayor indicated that in the light of the statement made by Councillor Stephens (Leader of the Council) and particular public interest in the proposed location of the Probation Hostel, the Minutes of the Housing Committee of 6 June 1995 would be brought forward and dealt with first under Item 5 in the Order of Procedure.

The Mayor accepted the petition and referred it to the Chairman of the Highways and Planning Committee for reference to that Committee.

22. QUESTION TIME

Moved by the Mayor and seconded by Councillor Durrant.

HEALTH AND ENVIRONMENTAL SERVICES COMMITTEE

Question by Councillor McLellan

"Does the Chairman of Health & Environmental Services Committee agree with me that the growth of weeds on pavements and in street gullies makes the City look a much poorer place. Can he further advise whether pavements and streets were treated with a weed killer substance as per the contract, and if so why this has not been effective. Finally can he advise me what he proposes to do to rectify the present unsatisfactory situation in many parts of the City."

Chairman's Reply

"Thank you. The first part of the question Madam Mayor, does the Chairman agree with me, yes I do. The growth of weeds on pavements and street gullies does make the City look a much poorer place and that is why it is exactly put in the contract to start with, it shouldn't happen. The new five year Street Cleaning Contract awarded to Gloucester City Services commenced full operation on 1 June 1995 after the usual 8 week contract initial period. This contract requires the contractor to implement a work plan for the removal of pavement weeds by a combination of both twice annually herbicide spray and physical removal of weeds by street cleaning operatives as part of their cleaning duties every two weeks in the outer area, and daily in the central area. This should ensure that the street cleaning standard required by the Council, through the contract with the Council, is achieved.

It is acknowledged that some areas of the City have evidence of pavement weeds which should be removed. These areas have either not been herbicide treated or not effectively treated by the street cleaning operatives. The contractor will shortly be providing the client with details of the street cleaning workplan and this will ensure early identification of those areas in the City that require attention to achieve contract standards. The effectiveness of the herbicide used in the treatment of pavement weeds or the twice annual application is not the primary issue. Both the client and Gloucester City Services contractors have contributed, together with ADAS and Severn Trent, to the Council's herbicide policy.

With the terminating of the old frequency based Street Cleaning Contract on 31 March 1995 and commencement of the new qualitative based code of practice Street Cleaning Contract post-commissioning period on 1 June 1995, there will inevitably be some operational difficulties requiring close co-operation between client and contractor. It is expected that these difficulties will not be repeated."

Supplementary question by Councillor McLellan

"I note the reply, but I am not impressed by the level and standard of service over the last year and hope these would improve in the forthcoming year."

Chairman's Reply

"Yes, the situation will improve next year, and the issue was, prior to the early part of this year, that the contract was put out on a frequency based concern, which meant that the street cleaning had to be done at certain times during the year. We now have the qualitative based Code of Practice where weeds should have been removed if and when they arise. What we are seeing at the moment is just one or two difficulties during this initial period. I hope that the difficulties would not be repeated throughout the rest of this year and certainly next year as well."
