115. LOCAL GOVERNMENT AND HOUSING ACT 1989 SECTION 45 BORROWING LIMITS

RESOLVED

- 1. That the overall borrowing limit for Gloucester City Council be set at £44.5 million for 2003/4.

- 3. That no loans be taken at interest rates which are variable at the lender's option and that the proportion of total interest payable by the authority on loans varied by external factors, be limited to 20% in 2003/4.
