85. ADMISSION OF HONORARY FREEMAN

- 85.1 The Council considered a report of the Leader of the Council asking it to confer the honour and title of Honorary Freeman of the City of Gloucester on the Right Reverend Michael Perham, Bishop of Gloucester in recognition of his significant contribution in the spiritual and temporal life of the City and his inspiration in promoting care and kindness between its citizens and communities within the City and wider Diocese.
