REPRESENTATIONS/OBJECTIONS OF THE CHIEF CONSTABLE OF GLOUCESTERSHIRE POLICE IN RELATION TO THE APPLICATION

Applicant- Mr Alan Whitehead

With regards to the current Application for an SEV, Gloucestershire Constabulary seek to object to the same on the basis of the Discretionary Grounds of Refusal only as set out in paragraph 4.2 of the Council's Sex Establishments Policy Statement [2014-2017] in that;

- 1. The Chief Constable asserts that although Mr Whitehead is, technically the named Applicant for the Licence, the business to which it relates would be managed by or carried on by him for the benefit of another namely Mr Ross Connock;
- 2. The Chief Constable makes this assertion because Mr Connock has had day to day management of Minx Licensed premises since 2012;
- 3. Further, Mr Whitehead has never been seen by officers who have attended at the premises on Licensing visits notwithstanding that he was the duly appointed Designated Premises Supervisor for a period of time and there is little evidence that he has actively promoted the Licensing Objectives;
- 4. Mr Whitehead is believed retired and in poor health in any event;
- 5. The Chief Constable asserts that Mr Ross Connock would be Refused the Grant of such a licence if he made the Application himself in that he was convicted of a number of accounting offences on or about the 9th September 2014 before the Exeter Crown Court;
- 6. These offences were connected to a Sexual Entertainment Venue, namely *Divas Gentleman's Club, Glover Lane in Newquay;*
- 7. Mr Connock is due for sentence in relation to these matters on the 24th April of this year;
