#### Overview

The Greyfriars area of Gloucester has been, and is continuing to be, subjected to a crucial re-development which is revitalising this part of the city centre. I have been a resident of Gloucester and the surrounding area for more than 35 years and, not only is this most welcome, but I have decided to invest in the area and make this my home.

At the heart of this redevelopment is the prestigious project being run by Linden Homes to provide high quality housing in this Conservation Area. It is an excellent example of a brown field development to turn a run down, neglected area of a city into a peaceful residential area for a community to thrive.

The Owners and Tenants have been subjected to considerable contractual restrictions imposed by the developers, City Council Planning Dept. and the Homes and Communities Agency. The idea of this type of venue is totally at odds with these restrictions. All concerned are trying to create a pleasant environment which is provides for a safe, healthy and good quality of life.

Specific Concerns

Public Nuisance - Noise

The first phase of the Greyfriars Development is more or less complete. It comprises some 60 homes or so. Some of these homes are no more 6 feet away from the proposed venue. It looks like it will be impossible to prevent undue noise pollution from the inside of the venue, let alone any outdoor area.

Noise issues are usually the responsibility of the Environmental Health Officer (EHO) who will be the first to receive a nuisance complaint. The local authority (as represented by the EHO) then has a duty to investigate and take action (through the service of notices) where statutory nuisances are found to exist (separated, yet not distinct, from the civil nuisance regime). At this stage, the role of the EHO is primarily reactive; as an enforcer.

However, the EHO also has a wider role to play as a statutory consultee; and this is where the process can come full circle. I would suggest that he/she is fully consulted at this application stage to provide comments relating to potential loss of amenity.

Then there is the issue of people coming to, and leaving from the venue. There is a through path from Kiln Close into Cromwell Street and beyond. In the evenings, we have already experienced noise from late night drunks using this through path, shouting and even using walls as public urinals. This is in a part of town which is largely quiet and residential. The effect of large numbers of people at night using this venue can only be largely detrimental to the area at large.

Public Nuisance - Crime & Safety

Along the lines of the previous point, the few revellers who use the route in Kiln Close have at times been abusive towards residents. Kiln Close is a small private road, with no public parking and private cars are exposed to the public. Who can possibly predict just how far public nuisance will deteriorate? What is predictable, however, is that it will simply not be possible for an effective policing action to be put in place given the demands on the local police.

Creating a venue which will impact this quiet street is not only foolhardy, but does a disservice to those that live here. We should have the right to peace, quiet and safety. I strongly object to the granting of any license for this venue.

Dear Sir/Madam,

I am a resident of Kiln Close writing to object to a late night licence being granted to the former nightclub on Brunswick Road.

There are plenty of bars, clubs, off-licences, etc. on Eastgate Street already, and I feel that it is unnecessary for another alcohol-based venue to open on Brunswick Road, especially one that stays open into the early hours. As we all know, alcohol is the main cause of disturbance, damage, violence, relationship breakdown and health problems in the UK, so it is not something that a local government authority should condone. That should be reason enough, but other reasons include:

- There is no security gate preventing revellers from entering the development, which puts property
  at risk of damage if somebody is stumbling around drunk/behaving aggressively.

I make the following comments on the Application:

#### Prevention of Crime and Disorder

The premises are extremely close to the residential development known as Greyfriars Quarter. Residents of Kiln Close are highly concerned at what will be a dramatic increase in foot traffic through the estate, which links to the Eastgate Street "night time economy" area. There have already been numerous incidents of public urination, as well as vandalism (Incident number: 443 22/05/2015) and littering: all caused by people who use Kiln Close as a shortcut. The police have been informed on many occasions.

Kiln Close is a private road. Parking is only allowed by those residents who have an allocated space. Illegal parking in the private road is already causing major problems, with residents often unable to enter and exit their reserved parking because of vehicles parked illegally.

Delivery and refuse vehicles have already been unable to access Kiln Close because of illegal parking.

There is no doubt that an all-day venue and nightclub next door will cause major problems and impede all legitimate traffic in Kiln Close, including that of the emergency services

Lack of CCTV coverage of Kiln Close makes the close and its residents vulnerable to the attention of the less law-abiding elements of society.

#### Public Safety

The premises front onto a busy part of Brunswick Road. There is considerable traffic from buses, taxis and vehicles using the Eastgate Centre Car Park. People under the influence of alcohol entering and leaving the premises are likely to be at unacceptable risk of injury from vehicular traffic. Users of other "night time economy" premises in Eastgate St are protected by the pedestrian only scheme.



Employment of licensed security personnel may ensure the safety of people using licensed premises, but in no way can guarantee their safety once off the premises.

A person who collapses after ingesting excess alcohol in the adjacent poorly lit alleyway or nearby streets would be at considerable risk of harm without an increased intensive police presence. At a time of cuts to our already overstretched police service, I fail to see how this additional "night time economy" area could be patrolled satisfactorily.

#### Public Nuisance

Noise from these premises cannot be contained without a complete rebuild. What may have been acceptable when the adjacent site was part of the Technical College (and non-residential) is not acceptable now that peoples' homes are immediately adjacent.

In fact the proposed venue comprises of a number of construction styles as it progresses away from Brunswick Road. Total soundproofing of these would be impossible.

The suggestion that an outside area is included would offer no containment of noise whatsoever.

Immediately adjacent to the premises is the Greyfriars Quarter development. This is a prestigious project offering high quality housing and is part of the Conservation Area. Owners and tenants have accepted considerable contractual restrictions imposed by the developers, City Council Planning Dept. and the Homes and Communities Agency. The proposed venue is totally at variance with these restrictions which exist to promote a safe, healthy, good quality of life within a pleasant environment.

To impose a nightclub/multipurpose venue just 6 feet away from peoples' homes (see attached photos) would be allowing a public nuisance that would affect large numbers of residential properties, and the peaceful enjoyment of their properties by the residents

#### The protection of children from harm

Greyfriars Quarter provides homes for large numbers of families with young children and babies.

Siting such a venue in close proximity would make it likely that children and young persons would witness drunkenness, public urination and foul language. In addition, children would be subjected to increased levels of noise from: the various activities at the venue, from additional vehicular traffic, and the noise made by customers of the premises in adjacent streets.

Children are particularly susceptible to noise as evidenced by the World Health Organisation. Their physical and psychological health is likely to suffer if this venue is allowed to go ahead:

"Impairment of early childhood development and education caused by noise may have lifelong effects on academic achievement and health. Studies and statistics on the effects of chronic exposure to aircraft noise on children have found:

consistent evidence that noise exposure harms cognitive performance;


consistent association with impaired well-being and motivation to a slightly more limited extent;

moderate evidence of effects on blood pressure and catecholamine hormone secretion."

#### Reason:

We live at Kiln Close, Gloucester which is approximately 150 meters from the entrance to the above premises and object to the issue of the licence on the grounds of Public Nuisance. We believe that the Public Nuisance would occur under a number of different situations.

- 1) Customers arriving at the premises
- 2) Parking in the Kiln Close area
- 3) Customers departing the premises
- 4) Re introduction of the taxi rank in Brunswick Road
- 5) Anti social behaviour rates in the area

# Customer arrival at the premises:

Currently there is limited noise disruption during the late evening on Friday and Saturday night in the Brunswick Road area. The licence states that the wish to attract customers who wish to eat within the premises in the early evening but also attract customers who have already eaten or have been drinking at other areas within Gloucester and beyond. It is not unreasonable to suggest that as customers arrive between the hours of 21.00 and 24.00, having been to other establishments that the level of noise and disruption will greatly increase within the area.

## Parking in the Kiln Close area:

Currently there are no restrictions on parking in Kiln Close. This results in people parking on the side of the street during shopping hours and at the weekend due to the close proximity to the city centre. As the close is within 2 minutes walk of the premises it is highly likely that customers will use the close for parking when visiting the premises. This will cause greatly increased vehicle movements, traffic noise and customer noise on arrival during the early evening. This problem will greatly increase as customers leave the premises

# Customers departing the premises:

There is already low level noise disruption in the area (as expected) during early Saturday morning and Sunday morning as revellers leave the city. This is mainly shouting, singing etc. and is only people passing through on their way home. The noise and inconvenience is insignificant to the potential disruption of hundreds of people spilling out onto Brunswick Street between 2.00 am and 3.00 am when the nightclub closes. Anyone who has been to a nightclub at closing time would be fully aware of the noise and disruption caused not only by loud happy revellers but also disputes, fallouts, fights, vomiting and toilet breaks that are a usual part of the scene. Despite the best will of the management and door staff the above will occur and will also spill out from the immediate area to the surrounding area of Kiln Close

Re - introduction of the taxi rank in Brunswick Road:

Currently vehicle movement on Brunswick Street in the early hours is limited and does not cause any disturbance. The re-introduction of the taxi rank will greatly increase vehicle movement and noise level in the area not only vehicles arriving and departing the taxi rank but also from customers queueing for the taxi. With the best will taxi ranks usually cannot keep up with demand (I assume 2.30 am to 3.30 am) this will result in customers staying within the area for a greater period of time and extend the noise level and associated problems for a longer period (see above).

Anti social behaviour rates in the area:

Before we moved to Gloucester in January we had to satisfy ourselves on a number of issues including:

The immediate surrounding area Proximity to the night-life in Gloucester The crime rate

When the premises was originally a nightclub (up to 2006 I believe) the surrounding area appears to have consisted of the Gloucester College with few residential premises in the immediate area, thus causing few problems with the location of the nightclub. Since that time the use of the area has changed considerably with a large residential population who have a right to a good nights sleep. Noise and disruption will commence with arrival of customers at 21.00 and continue through until the closure of the premises and dispersion of the crowd at about 4 am (a period of 14 hours every weekend and also other days throughout the year)

The REPORTED crime rate in GL1 for the period May 2014 to April 2015 shows 1839 incidents of Anti social behaviour of which approximately 40% were in the Eastgate Street area. These are reported incidence and we can suspect that the level of unreported Anti social behaviour is higher.

The number of incidents shown in the Brunswick Road / Kiln Close area was ZERO.

Conclusion:

The area around Jumping Jacks has changed and is now a vibrant residential area with little noise disturbance and zero anti social behaviour. The introduction of a nightclub into the street will only greatly increase these levels and I object to the granting of the licence on these grounds

We make formal representation against the licensing application of 5-7 Brunswick Road by Supreme services (Glos).

Our concerns are listed below -

Parking – Kiln Close is a residential area, there are signs already in place to the effect of "No Parking. Residents only" It is already difficult enough for my partner to park his vehicle outside of the apartment when he is home. This is already ignored and opening a venue each night until 0230 and 0300 will only serve to make this situation worse from designated drivers, drunk drivers and vehicle being left over night to be collected.

Traffic flow around rush hour is heavy and several left vehicles will hinder residents' ability to exit Kiln Close. On the matter of left vehicles, CarillionAmey have previous refused to collect residents' rubbish as the refuge wagon could not fit between left vehicles. There have also been concerns raised with regards to access of emergency vehicles.

Noise – music – from our apartment we already hear music noise from concerts played at Kingsholm Stadium. We will therefore be able to hear the music intended to be played at the venue. This will not only disturb our sleep but means we will not be able to have any doors or windows open without being subjected to the noise.

Noise – vehicles – we anticipate patrons will require taxi's to return home. There will be an increase in vehicles travelling along Brunswick Road, waiting along Brunswick Road and most likely will wait directly below our apartment which overlooks the road. This noise will again disturb our sleep and is completely unacceptable. Again we will not be able to open doors or windows without hearing the increased vehicle noise. The noise of a vehicle door opening/closing wakes me each time and is unbearable.

Noise – emergency vehicles - there will without doubt be an increase in emergency vehicles in the immediate area. These vehicles are noisy, the emergency beacons illuminate entire rooms in our home and people that follow these vehicles/are the cause of the vehicles presence both produce an unacceptable noise at any time of the night.

Noise – patrons – in particular patrons under the influence of alcohol. Currently patrons walk along Brunswick Road and in to the town centre and a few. Should this venue open there will without doubt be an increase of patrons/pedestrians in the immediate area. They will be in the area for a number of reasons such a waiting for a taxi, they may have been ejected from the premises or eating food, this list is not exhaustive. This will increase the noise heard by all residents in Kiln Close in particular by our apartment. This will again disturb sleep and is completely unacceptable, this is a family home and drunken noises should not be heard as the norm.

Crime & Safety – as a female I will no longer feel safe in my own community with several people under the influence of alcohol littering the area. I do not want to be faced by drunken people who may intend to assault me violently or sexually. I do not wish to have drunken slurs forced in my direction and I most certainly do not want any of these people to know where I reside. There will be an increase of crime in relation to vehicles being damaged, broken in to and vandalised as a start. This will in turn negatively affect the value of our property. All of which are completely unacceptable.

Litter – with the increase of people in the immediate area there will be an increase in litter dropped and vomit on the streets. Kiln Close is home to many families with young children, this is not something they should see and be forced to grow up around.

We hope this highlights some of our concerns with regard to the licencing of 5 - 7 Brunswick Road.
