In my lease I have a restriction that states I cannot make a noise such as running washing machines, vacuums, play loud music after 9pm and before 9am, if I do it will be treated as anti social behaviour, if I have that in my lease this development in unit a should have the same, making noise outside these times would be anti social behaviour from them.

Having a licence 12hours a day 7 days a week will not give me a break from this noise. I would like to see the times reduced and not have it 7 days a week

I would like to formally object to the above application on the grounds of prevention of public nuisance.

On the basis of the evidence seen in the docks since Wetherspoons were granted a licence the whole fabric of living in the docks as a safe environment has been destroyed.

Most nights we have drunken individuals falling into the water, urinating, vomiting and shouting abuse at residents.

Serving alcohol for 12 hours from 11am - 11pm 7 days a week (as the application suggests) will, I am sure, be a huge contributing factor to causing a nuisance to the residents who live above and in the surrounding area of the restaurant, along with the noise from the piped music, delivery of produce to the premesis at ridiculous times in the day, and customers departing from the premesis at 11pm-12am.
