Thank you for making the time to meet with us last week. Your application is fine from a police perspective but I just needed to ensure that your licensing objectives were made more specific.

The age scheme that you will adopt is the Challenge 25 scheme & you will display posters to that effect. Your staff will be trained re the Challenge 25 scheme & you will keep training records & undertake regular refresher training. You will keep a record of all refusal of sales for either under age or drunken persons.

CCTV will be recording when the premises is trading & shall be maintained in good working condition. It will be capable of recording good quality images & storing them for a minimum of 28 days or 14 for a digital system. There should always be a member of staff available who is able to download images to disc or USB stick for Police, Council or Trading Standards officers when requested.

If you can let me know asap if you are happy with the above as discussed & I will advise the Council.
