3. From Councillor Hilton to the Cabinet Member for Performance and Resources

It is now six months since the cyberattack on the Council's ICT systems. Can you give me a date when the Planning Portal will be fully restored?

### Response:

The Planning Portal is a third party service by PortalPlanQuest Limited which is a joint venture between TerraQuest Solutions Limited and the Department for Levelling Up, Housing & Communities. Applicants can use this service to submit planning applications to the council and these continue to be received and processed manually. Functionality related to viewing the progress of these applications will be available via our website later in the year.

4. From Councillor Hilton to the Cabinet Member for Performance and Resources

On the City Council website it says in relation to the cyber attack: `We are currently unable to process applications to be entered on to the electoral register or changes to existing registrations'. In what way has the cyberattack compromised the accuracy of the electoral register?

### Response:

It has been possible to restore the electoral register held by the council at the time of the cyber incident to the precise date of the incident i.e. there is no gap in the information because it has not been necessary to return to an earlier back up of the register. Any online applications to register made since the cyber incident are stored on the Government's IER Digital Service and will be processed once testing on the recovered system has been completed, along with any paper applications received, any changes, and any requests to be removed.

While the register itself has been recovered intact, including details of all registered electors and the markers that tell us specific information about them, it has not been possible to recover images held outside the core database. As such, we will be writing to all our postal voters to ask them to complete a new application form, providing their date of birth and a signature specimen, to ensure they can vote by post at future elections. This exercise will also help us to get ahead of the curve when the requirement to reapply for a postal vote reduces from 5 years to 3 years in January 2024.

The Council continues to work with our external auditors Deloitte to complete the 2020/21 financial statements. The majority of the audit is completed, and we hoped to sign the accounts earlier in 2022. A recent CIPFA consultation into Infrastructure Assets, has resulted in Deloitte putting a moratorium on signing 2020/21 accounts, where Councils have material infrastructure assets. We are working with Deloitte around this consultation, both parties are aiming for the accounts to be signed by the next Audit and Governance committee in July 2022.

# 10. From Councillor D Brown to the Leader of the Council

Is any effort being made, or planned, to reduce the nuisance(s) caused by seagulls in the city centre and across Gloucester?

### Response:

Seagulls, or Herring Gulls and Lesser black backed Gulls as we have in Gloucester are protected by law. Therefore, it is illegal to injure the birds, eggs, and their nests without consent from Natural England.

Natural England only issue licenses to allow interference with nests and eggs in very specific situations. The person applying for the license must be able to demonstrate that action is needed to preserve public health or public safety which require a significant amount of evidence for each individual case and only applies to the unique property affected. Gulls causing a nuisance do not fall into this category, specifically Natural England have advised a license won't be granted for problems involving bird noise, fouling and or property damage.

Currently we are advising deterrence as the appropriate solution for long-term non-lethal control.

We strongly urge all owners or occupiers of buildings that have or may attract roof-nesting gulls to add deterrent measures suitable to the individual building. Please refer to this leaflet for further information

## 11. From Councillor Wilson to the Cabinet Member for Environment

The annual green waste invoice, which has just been sent out to residents, contains the following statement: `Following a consultation, the council has decided not to operate the garden waste collection service in December and January'.

What form did this consultation take? When was it carried out? How many residents responded?

### Response:

The budget consultation was undertaken as a survey of local residents. It was hosted online and was advertised via the council's communications team on all channels.

It was also advertised on the council's website under 'current consultations' - Current consultations - Current consultations - Gloucester City Council
The consultation was also sent to the following:

• Citizens Advice Bureau

- MP's Office
- GARAS
- GL Communities
- Gloucester City Homes
- Gloucester Law Centre
- NHS locally for wider cascade

The consultation was open from 06 December 2021 until 14 January 2022. 95 residents responded to the survey - specifically the question about garden waste sought residents opinions on the following:

The City Council are considering changing our garden waste service to run for ten months a year, not running in December and January as evidence shows that very little garden waste is produced in those two months, with just 156 tonnes in January 2021, compared to 975 tonnes in June 2021. By changing the service to a ten month operation, the Council could achieve vital carbon savings. In addition, our teams could focus on collection of other household waste at a time of year which is traditionally busy for other domestic refuse collections.

Would you support this change in service to contribute towards the City Council's carbon reduction target?

77 respondents (82%) would support the change, 10 respondents would not be supportive of the change and 7 respondents were undecided.

The consultation was Appendix 7 to the Budget Report in the Budget Council, held on 24 February 2022, and Appendix 6 Fees and Charges booklet details the price and period.

What are the key dates for submission of the outline planning application for the Podsmead regeneration scheme and how can residents make comments etc?

### Response:

Residents living within the boundary of any planning application and those immediately adjacent to it will be notified in writing and advised how to make comments. Site notices and press notices will also be displayed. Residents have 21 days from the date of the notification to comment on planning applications.

GCH have indicated that an application is likely to be submitted during the summer however this date is not confirmed and not in the control of the council.
