## NOTES

### Disclosable Pecuniary Interests

The duties to register, disclose and not to participate in respect of any matter in which a member has a Disclosable Pecuniary Interest are set out in Chapter 7 of the Localism Act 2011.

Disclosable pecuniary interests are defined in the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 as follows –

<u>Interest</u>	<u>Prescribed description</u>
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain.
Sponsorship	Any payment or provision of any other financial benefit (other than from the Council) made or provided within the previous 12 months (up to and including the date of notification of the interest) in respect of any expenses incurred by you carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
Contracts	Any contract which is made between you, your spouse or civil partner or person with whom you are living as a spouse or civil partner (or a body in which you or they have a beneficial interest) and the Council (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged
Land	Any beneficial interest in land which is within the Council's area.  For this purpose "land" includes an easement, servitude, interest or right in or over land which does not carry with it a right for you, your spouse, civil partner or person with whom you are living as a spouse or civil partner (alone or jointly with another) to occupy the land or to receive income.
Licences	Any licence (alone or jointly with others) to occupy land in the Council's area for a month or longer.
Corporate tenancies	Any tenancy where (to your knowledge) – (a) the landlord is the Council; and (b) the tenant is a body in which you, your spouse or civil partner or a person you are living with as a spouse or civil partner has a beneficial interest
Securities	Any beneficial interest in securities of a body where – (a) that body (to your knowledge) has a place of business or land in the Council's area and

(b) either –

- i. The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
- ii. If the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, your spouse or civil partner or person with whom you are living as a spouse or civil partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

For this purpose, “securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

NOTE: the requirements in respect of the registration and disclosure of Disclosable Pecuniary Interests and withdrawing from participating in respect of any matter where you have a Disclosable Pecuniary Interest apply to your interests and those of your spouse or civil partner or person with whom you are living as a spouse or civil partner where you are aware of their interest.

1.	From Councillor Hilton to the Cabinet Member for Housing and Planning Strategy	In the last six months has there been any planning pre-application discussions held between this council and the owners of the former Sainsbury's store on Northgate Street?
	<b>Response:</b> No there have been no discussions with regards to this site in the last 6 months.	
2.	From Councillor Hilton to the Cabinet Member for Performance and Resources	How many of the council's IT servers are being replaced or rebuilt following the cyber attack?  Please give total number of servers we had in operation and the number adversely affected.
	<b>Response:</b> As a precautionary measure, based on the information provided by the National Cyber Security Centre, we have taken the decision to rebuild all of the on-premises servers. The Council's virtual platform is hosted on 10 physical servers, all of these servers are being rebuilt.	
3.	From Councillor Pullen to the Cabinet Member for Performance and Resources	What steps are being taken by the council to ensure that its procurement processes no longer involve goods, services or investments that could originate or have connections with Russia?
	<b>Response:</b> As part of our procurement procedures the Council continues to require all new suppliers to be assessed when set up to do business with the Council. As part of our procurement requirements, we need to know who our suppliers are and that they are suitable to work with. This will be verified in line with United Kingdom Government sanctions.	
4.	From Councillor Pullen to the Cabinet Member for Performance and Resources	How is the council going to ensure that every resident who does not pay Council Tax by direct debit is aware of their entitlement and receives their £150 rebate promptly and efficiently?
	<b>Response:</b> A notice was sent out with Council tax bills, highlighting the rebate. The Council continues to update its website in respect of the rebate, any updates on the	

	<p>process will be added to the website. As further details are available communications will be made both to Members and all available communication channels.</p>	
5.	<p>From Councillor Hyman to the Cabinet Member for Environment</p>	<p>22 households in Elmbridge had their garden waste contracts cancelled and the reason given was that the vehicle could not get down the narrow streets.</p> <p>At a presentation given by Ubico, I asked if they would be able to collect from narrow streets and they said they could resolve this with the council should they be successful in obtaining the contract.</p> <p>As Ubico will soon be taking over the contract, will you review this situation and work with Ubico so that the households referred to can be put back on the garden waste contract?</p>
<p><b>Response:</b></p> <p>To supply an appropriate 7.5 tonne vehicle and crew to collect from the small number of houses on roads too narrow to accommodate a 26 tonne RCV, a further investment of £100,000 per annum would be required. This is not considered an economic investment.</p> <p>The garden waste service has never been offered to all households in the city because to be an efficient, effective service a 26 tonne RCV is needed to collect this type of waste, the payload of which exceeds 10 tonnes and also has the necessary compaction.</p>		
6.	<p>From Councillor Conder to the Cabinet Member for Planning and Housing Strategy</p>	<p>The cabinet member reported at the last meeting a reduction in the numbers of rough sleepers in Gloucester.</p> <p>However, the night shelter only provides accommodation during the winter months and is due to close soon. Given the continuing impact of Covid, the reduction in Universal Credit, and the anticipated rise in tenants being given notice to quit, will the Cabinet member consider funding the night shelter throughout the summer months?</p>
<p><b>Response:</b></p> <p>All individuals who are sleeping rough in Gloucester either have been offered accommodation or have access to accommodation that they can return to, and some individuals choose to access Gloucester City Mission's night shelter rather than accept the Council's offer of accommodation. When the night shelter closes, those individuals will be able to access the Council's offer of accommodation. The Council is committed to ending rough sleeping and officers work with individuals to secure appropriate sustainable accommodation solutions. At the present time, funding the night shelter throughout the year does not form part of the countywide rough sleeping pathway.</p> <p>To date we have not experienced the anticipated level of households presenting as homeless following the end of the eviction moratorium. Where Council officers are unable to intervene to prevent evictions, the Council has a range of measures in place to support households who lose their homes including the provision of suitable emergency and temporary accommodation.</p>		

7.	From Councillor Castle to the Cabinet Member for Environment	Please provide a list or map of the locations of the 83 new bins mentioned in the city council budget debate. What service agreements are in place with Ubico to service these bins when the new contract comes online on April 1st?
<b>Response:</b>		
<p>The attached list shows where new bins have been allocated to from the WRAP grant funding (please note at some locations there are more than one bin. Ubico have committed to GPS map and condition survey all litter and dog bins in the city so all locations will be readily available through the Council's mapping system.</p> <p>The new contract identifies how the contractor will service the bins at points 1.1.8 and 1.1.9 see below</p> <p><i>The emptying of litter bins in all areas shall be included as part of the regular services. The company shall ensure that litter bins are emptied at frequencies to ensure they do not overflow at any time with a minimum frequency of every 14 days. Upon discovery through self-monitoring or when instructed by the Council's representative, any litter bin that is full within 1 hour for zone Z or H areas and within the same day (or if reported after 13.00 by the end of the next day) for all other areas. At the time of emptying any ash trays will also be emptied and left in a clean condition and in the case of bins in the City Centre the bin shall be left in a clean condition including washing down if necessary. Any waste left beside the bin will also be emptied at the same time as emptying the bin.</i></p> <p><i>The Company shall also empty dog waste bins including bins that are dual use for litter and dog waste at a frequency no less than weekly. Where required after emptying, the bin shall be disinfected and left in a clean condition.</i></p>		
8.	From Councillor Field to the Cabinet Member for Communities and Neighbourhoods	There are several clothes banks for the '2Rs Community Resource Centre' around the city, including in my ward of Podsmead on Burns Avenue, in Tuffley by the Seventh Avenue shops and in Chatsworth Avenue, and in Grange by Homleigh shops. An internet search shows that 2Rs was a Wolverhampton-based charity and that it was dissolved on 31st March 2021. Can the cabinet member explain to council why Gloucester residents were donating to a charity based in Wolverhampton? What was the financial arrangement, if any, that the council had with 2Rs to allow them to site their clothes banks on council property? Finally, as these clothes banks can be a magnet for fly-tipping and as the charity is now defunct, can we get the clothes banks removed?
<b>Response:</b>		
The City Council does not approve the siting or management of clothes banks. If they are on private land such as a supermarket car park, permission will be given by the landowner. If they are on public land then permission will be granted by Gloucestershire Highways.		
9.	From Councillor Field to the Cabinet Member for Environment	Podsmead has suffered repeated missed collections of waste and/or recycling in recent months. Often residents are unaware that the

		collections are being missed out, and they don't know to take their rubbish/recycling back inside for the following week. This leads to litter blowing around the streets, which was exacerbated by the recent storm. What measures are being taken to ensure that the new contract with Ubico delivers a better service to residents, and what are we doing to reassure residents that things will improve?
<b>Response:</b>		
<p>Unfortunately, we continue to have a driver shortage, and this has affected recycling collections in every ward. Refuse collections should not however have been affected, we have maintained waste collections, green waste collections and food waste collections throughout. If waste has been missed it is because of another issue such as a truck breakdown or access issues, in this case it should be reported by the end of the next day and it will be returned to.</p> <p>During what has been a very challenging period we have attempted to reduce inconvenience to residents as much as possible by ensuring that the same properties are not missed two weeks in a row. Each day the Council website is updated with information about what to do with recycling that has not been collected and the ward Councillors for the affected wards are also notified.</p> <p>Ubico have already placed a job advert to recruit more drivers. There is an opportunity for any drivers working on their other contracts to relocate to Gloucester City if they wish and Ubico have a earn and learn programme where they will cover the cost of any member of staff to train for and obtain a HGV licence.</p>		
10.	From Councillor Field to the Cabinet Member for Culture and Leisure	Aetheflaed, Margaret of Anjou, King Richard III and Ivor Gurney are some of the major figures in our city's history. What plans are there to feature them more in the city, for example in the Museum of Gloucester or in statues and public art?
<b>Response:</b>		
<p>The city already celebrates these figures through public art memorials, statues, displays in the museum and re-enactment events. There is material and information relating to Aetheflaed, Margaret of Anjou, King Richard III and Ivor Gurney on display in the Museum of Gloucester and in the public realm. One of the recent Snow Globes (as part of Bright Nights festival) featured Aethelflaed – the artwork will be displayed in the Museum. Within the past year a re-enactment of the journey of Margeret of Anjou was supported. The approved designs for the commissioned windows for the Transport interchange will feature scenes from Gloucester's history. There are no plans for additional permanent public memorials in relation to these figures at this time. However, the city council will continue to support activity, where it can, through marketing &amp; promotion of events that highlight and celebrate Gloucester's history.</p>		
11.	From Councillor Field to the Cabinet Member for Culture and Leisure	What plans are there for the Jubilee celebrations?
<b>Response:</b>		
<p>Jubilee Celebrations in the city start when a Lamprey Pie is presented to the Lord Lieutenant who will receive this on behalf of the Queen. On Thursday 2<sup>nd</sup> June the city will participate in a beacon lighting event on Robinswood Hill as part of the national celebrations, which will include a bugler, the Town Crier and a piper. Military cadets will attend and the Lord Lieutenant will nominate a</p>		



	<p>member of the public to light the beacon. Gloucester Primary Schools are creating Flags of Hope which will be displayed in a procession through the city centre to be displayed in the Museum of Gloucester or in Kings Square afterwards.</p> <p>Gloucester Tall Ships will celebrate the Jubilee with ships encouraged to use bunting and the city centre dressing will be appropriately colour-themed. The lighting in Kings Square will also be themed for the occasion.</p>
12.	<p>From Councillor Field to the Cabinet Member for Culture and Leisure</p> <p>Do you intend to try for City of Culture again?</p>
	<p><b>Response:</b></p> <p>We will work with Gloucester Culture Trust and others to understand if there is an appetite for doing so and the council will keep an open mind about this and consider its options.</p>
13.	<p>From Councillor Chambers-Dubus to the Cabinet Member for Culture and Leisure</p> <p>On the 2<sup>nd</sup> February 2022 Gloucestershire Live reported that at the overview and scrutiny meeting on the 31st January 2022, Cllr Pullen commented that he was pleased to see in the Tourism and Marketing Plan for 2022 that the council would not work with the Sun or Daily Mail because of their record of publishing hate speech. Cllr Pullen was then told that the inclusion of that statement had been a mistake.</p> <p>Could Cllr. Lewis please tell us who's decision it was to remove that commitment from the Tourism &amp; Marketing Plan?</p>
	<p><b>Response:</b></p> <p>I (Councillor Lewis) requested that this was removed.</p>
14.	<p>From Councillor Conder to the Leader of the Council</p> <p>Spreadeagle Court is a gateway building in close proximity to the Forum development. It is now in very poor condition, with missing slates and several broken windows.</p> <p>Has the Council had any recent discussions with the owners regarding the future of this once-proud building?</p>
	<p><b>Response:</b></p> <p>Council officers have liaised with the property owners for some time with a view to improving its condition and identifying a sustainable future use. To date it has not been possible to facilitate the necessary development, however officers continue to monitor the site and work with the owners.</p>
15.	<p>From Councillor Hilton to the Cabinet Member for Performance and Resources</p> <p>The council has already gathered £630,000 of funds to assist in the recovery of the council's IT systems.</p> <p>I don't believe this is nearly enough to fund a full recovery.</p> <p>What effort is the cabinet member taking to secure further funds from the government or other external sources?</p>
	<p><b>Response:</b></p>

	We will continue to explore all available external sources of funding including Cyber Security Fund. The Leader, Managing Director and Section 151 Officer have met with a DLUHC minister regarding potential support from government and will be following this up with the Department.	
16.	From Councillor Hilton to the Cabinet Member for Performance and Resources	Has the city council exchanged contracts over the sale of Herbert, Kimberley and Phillpotts warehouses?
	<b>Response:</b>	
	No. Agreement in principle has been reached, but formal exchange will not be made until planning permission is received.	
17.	From Councillor Hilton to the Cabinet Member for Performance and Resources	As suggested in the local media can you now confirm whether or not the cyber attack that hit the council's IT systems in December was caused by hackers based in Russia?
	<b>Response:</b>	
	As Councillors are already well aware, we are unable to share any further details concerning this incident as it is an active investigation.	
18.	From Councillor Hilton to the Cabinet Member for Performance and Resources	Modern Dot Gov did provide both members of the council and the public the opportunity to search for old committee and council papers going back many years.  When will this system be fully operational again?
	<b>Response:</b>	
	Civica Modern Gov have been asked to work up a proposal to restore this application in the Cloud. To date we have not received the proposal so are unable to answer this question at this time.	
19.	From Councillor Hilton to the Cabinet Member for Performance and Resources	When will the council's Uniform data system for planning, licensing and environmental health be fully operational, following its disablement due to the cyber attack?
	<b>Response:</b>	
	Idox have been asked to work up a proposal to restore this application in the Cloud. This proposal has been received and signed off – we are awaiting the detailed project plan from Idox. Once received, we will be able to provide milestone dates.	
20.	From Councillor Hilton to the Cabinet Member for Performance and Resources	Does or did this council have insurance cover against the cost of recovery of its IT systems in the event of a cyber attack?  A simple yes or no answer would do.
	<b>Response:</b>	
	The Council did not have specific cyber insurance.	
21.	From Councillor Wilson to the Cabinet Member for Performance and Resources	The National Fraud Initiative (NFI) matches electronic data within and between public and private sector bodies to prevent and detect fraud. Gloucester City Council is part of this initiative and is required to submit data to the NFI on a regular basis.  The Council's current ICT position has impeded the Council's ability to review the NFI matches. The NFI and Cabinet Office have been advised of the

		<p>situation and have taken the interim action to suppress access to all Gloucester City Council matches by users with a Gloucester City email address.</p> <p>When do we expect this block on all matches from Gloucester City Council to be lifted?</p> <p>Given that this is an important tool in the detection and prevention of fraud will the data from the period we were blocked still be analysed retrospectively and the appropriate action taken?</p>
	<b>Response:</b>	
	<p>The National Fraud Initiative (NFI) matches were up to date at the time of the cyber incident. At this time, we do not have a date when we may be able to access the NFI (hosted by Cabinet Office), however, we are working with government departments to offer them the relevant assurance they require as we restore and rebuild our systems. Once we have restoration and full NFI access, we will be in a position to continue with our NFI work, which will include analysing all the relevant data, even any which may have been submitted during our 'down time' and ensuring that we take the appropriate action.</p>	
22.	From Councillor Wilson to the Cabinet Member for Performance and Resources	What is the latest estimate as to when we can expect all Council IT Systems to be back fully up and running?
	<b>Response:</b>	
	<p>The recovery is being worked on in a phased approach: priority applications have been stood up in skeleton fashion in phase 1. The second phase broadens the recovery out to include restoring secondary priority applications in a cloud environment and a laptop renewal programme. Further phases will then bring up the remainder of the IT systems. It is not possible at this time to give a precise estimate as to when all of these phases will be complete.</p>	
23.	From Councillor Wilson to the Cabinet Member for Planning and Housing Strategy	Is Gloucester City Council sharing sensitive details of homeless people with the Home Office which could lead to their deportation?
	<b>Response:</b>	
	<p>The Council's homelessness officers refer a small number of individuals to the Home Office's Rough Sleeping Support Service (RSSS) to clarify their immigration status. These immigration status checks are completed and returned within 24 hours, enabling the Council to quickly establish the individual's entitlement to public funding and their ability to access support services.</p> <p>Where the Council makes a referral to this service the individual provides consent for their personal information to be passed to the RSSS. The consent form clearly sets out that while the RSSS is not intended to identify or locate immigration offenders there is a possibility that if the individual has no lawful basis to remain in the UK that they may be required to leave the country.</p>	
24.	From Councillor Sawyer to the Cabinet Member for Environment	What measures are in place to ensure the community are involved with the design of the green space element of the Paygrove Lane development?
	<b>Response:</b>	

	<p>The land in question belongs to the County Council but we understand they wish to build houses on it, the open spaces team have not yet seen the planning application. As with any development if there are associated s106 monies for open spaces we always consult with residents, we will not be in a position to do this until we know what the plans are.</p>	
25.	<p>From Councillor Sawyer to the Cabinet Member for Environment</p>	<p>There seems to have been a system in recent weeks of missing out certain roads from the recycling collection, and collecting a double load the next week, in order to manage the driver shortage. Councillors are being informed by email which roads have been missed and many are doing what they can to publicise the changes and to remind residents to take their recycling back in. But what is the council doing to make residents aware of these changes, and will the practice be carrying on for much longer?</p>
<p><b>Response:</b></p> <p>The national shortage of HGV drivers is still partially affecting recycling services. As well as notifying ward councillors by email daily, of the roads that have not been collected, the Council website is also updated every day that collections have not been completed with the information and what residents should do with recycling.</p> <p>Ubico understand the situation and know they need to recruit more drivers; they have the same recruitment issues on their other contracts. All Ubico contracts in Gloucestershire have aligned pay rates for drivers and Ubico have placed adverts for drivers in readiness for contract start.</p>		
26.	<p>From Councillor Sawyer to the Cabinet Member for Communities and Neighbourhoods</p>	<p>What are you doing to ensure community safety in areas of the city outside the city centre, such as Longlevens?</p>
<p><b>Response:</b></p> <p>The city council works in partnership with various organisations, including the police, county council and homeless and housing groups, to deliver community safety work throughout the city. Residents can contact SOLACE regarding incidents relating to Anti-Social Behaviour through <a href="mailto:community.wellbeing@gloucester.gov.uk">community.wellbeing@gloucester.gov.uk</a>.</p>		
27.	<p>From Councillor Sawyer to the Cabinet Member for Performance and Resources</p>	<p>What help is available from the city council for any people struggling as a result of the cost of living crisis?</p>
<p><b>Response:</b></p> <p>Gloucester City Council will be dispensing the £150 energy rebate to eligible city households – the council's website is being regularly updated with current information about this scheme: <a href="#">Council Tax Energy Rebate - Gloucester City Council</a></p> <p>In addition, residents may be entitled to a variety of benefits, the City Council offer support with Housing Benefit and Council Tax Support – information about these benefits is available on the website: <a href="#">Apply for Housing Benefit - Gloucester City Council</a> or there are links to other organisations (such as the Department for Work and Pensions) who offer alternative benefits.</p>		

City residents who rent their homes and receive Housing Benefit or the housing element of Universal Credit, who are struggling with rent shortfalls may apply for a discretionary housing payment (DHP). This is a short term award which can help residents meet a shortfall between their benefit and their rent payment, whilst sourcing more suitable, sustainable accommodation. A DHP can also help with a deposit or rent in advance for a more sustainable property and moving costs.
