NOTES

Disclosable Pecuniary Interests

The duties to register, disclose and not to participate in respect of any matter in which a member has a Disclosable Pecuniary Interest are set out in Chapter 7 of the Localism Act 2011.

Disclosable pecuniary interests are defined in the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 as follows –

<u>Interest</u>	<u>Prescribed description</u>
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain.
Sponsorship	Any payment or provision of any other financial benefit (other than from the Council) made or provided within the previous 12 months (up to and including the date of notification of the interest) in respect of any expenses incurred by you carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
Contracts	Any contract which is made between you, your spouse or civil partner or person with whom you are living as a spouse or civil partner (or a body in which you or they have a beneficial interest) and the Council (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged
Land	Any beneficial interest in land which is within the Council's area. For this purpose "land" includes an easement, servitude, interest or right in or over land which does not carry with it a right for you, your spouse, civil partner or person with whom you are living as a spouse or civil partner (alone or jointly with another) to occupy the land or to receive income.
Licences	Any licence (alone or jointly with others) to occupy land in the Council's area for a month or longer.
Corporate tenancies	Any tenancy where (to your knowledge) – (a) the landlord is the Council; and (b) the tenant is a body in which you, your spouse or civil partner or a person you are living with as a spouse or civil partner has a beneficial interest
Securities	Any beneficial interest in securities of a body where – (a) that body (to your knowledge) has a place of business or land in the Council's area and

(b) either –

- i. The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
- ii. If the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, your spouse or civil partner or person with whom you are living as a spouse or civil partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

For this purpose, “securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

NOTE: the requirements in respect of the registration and disclosure of Disclosable Pecuniary Interests and withdrawing from participating in respect of any matter where you have a Disclosable Pecuniary Interest apply to your interests and those of your spouse or civil partner or person with whom you are living as a spouse or civil partner where you are aware of their interest.

Clarification of status of Gloucester City Plan

The published officer report erroneously refers to the Gloucester City Plan as having an 'emerging' status in the following paragraphs:

- 6.6
- 6.9
- 6.13
- 6.15
- 6.24
- 6.25
- 6.26

The Gloucester City Plan was adopted on 26th January 2023. It is no longer an emerging document. The policies contained within the Gloucester City Plan can be afforded full weight.

Additional Neighbour Comments

Since the publishing of the officer report, two further neighbour comments have been received.

One was a letter of objection. This letter raised the following issues:

- Concern that granting permission to another hot food takeaway within this residential area would lead to negative health outcomes.
- Concern over the potential impacts on traffic and parking within the local area. Particular concern was expressed that the introduction of a takeaway would give rise to greater 'dwell time' amongst parked cars, and that the lack of allocated parking means this site is ill-suited to a high intensity of car visits.
- Concern over the potential for littering in the Robinswood Hill High Landscape Sensitivity Area
- Concern over the potential for adverse fumes and odour to be emitted from the takeaway.

The other was a letter of support. This letter made the following points:

- The availability of nearby on-street parking and the proximity of the Robinswood Hill Country Park car park should provide ample parking for patrons.
- The proprietors of the shop are responsible and maintain a high level of hygiene and cleanliness.
- The shop is a valued community asset and its proprietors enjoy good relations with its patrons and the wider community.
