NOTES

Disclosable Pecuniary Interests

The duties to register, disclose and not to participate in respect of any matter in which a member has a Disclosable Pecuniary Interest are set out in Chapter 7 of the Localism Act 2011.

Disclosable pecuniary interests are defined in the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 as follows –

recultary interests) Regulations 2012 as follows –	
<u>Interest</u>	Prescribed description
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain.
Sponsorship	Any payment or provision of any other financial benefit (other than from the Council) made or provided within the previous 12 months (up to and including the date of notification of the interest) in respect of any expenses incurred by you carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
Contracts	 Any contract which is made between you, your spouse or civil partner or person with whom you are living as a spouse or civil partner (or a body in which you or they have a beneficial interest) and the Council (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged
Land	Any beneficial interest in land which is within the Council's area.
	For this purpose "land" includes an easement, servitude, interest or right in or over land which does not carry with it a right for you, your spouse, civil partner or person with whom you are living as a spouse or civil partner (alone or jointly with another) to occupy the land or to receive income.
Licences	Any licence (alone or jointly with others) to occupy land in the Council's area for a month or longer.
Corporate tenancies	Any tenancy where (to your knowledge) –
	 (a) the landlord is the Council; and (b) the tenant is a body in which you, your spouse or civil partner or a person you are living with as a spouse or civil partner has a beneficial interest
Securities	Any beneficial interest in securities of a body where –
	 (a) that body (to your knowledge) has a place of business or land in the Council's area and

- (b) either
 - i. The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - ii. If the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, your spouse or civil partner or person with whom you are living as a spouse or civil partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

For this purpose, "securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

NOTE: the requirements in respect of the registration and disclosure of Disclosable Pecuniary Interests and withdrawing from participating in respect of any matter where you have a Disclosable Pecuniary Interest apply to your interests and those of your spouse or civil partner or person with whom you are living as a spouse or civil partner where you are aware of their interest.

Agenda Item 5 - 23/00341/FUL 15 Green Lane – Late Material

1.0 - Clarification of relevant planning policies

The published committee report erroneously omits Policy A5 (Specialist Housing) from the list of relevant planning policies (Section 3.5).

Policy A5 is a relevant policy and is discussed at length in sections 6.9-6.13 of the report.

2.0 – Neighbour Amenity

Information has been provided by the applicant that confirms *Connections 2 Independence* (henceforth C2I, the operator of the proposed children's home) have a 'nominated representative' who would serve as a primary contact should members of the community have any concerns regarding noise, nuisance or other issues at 15 Green Lane.

The applicant confirmed that an 'Open Day' event was conducted on 22.07.2023; all of the nearby properties along Green Lane and Coppice Mews were invited to attend. These invitation letters included names and contact details of two individuals from C2I. The applicant confirmed in writing on 28.09.2023 that these two individuals would serve as 'nominated representatives' with whom contact could be made were issues to arise. These invites also included the standard 'office number' for C2I. C2I also have cards that include these contact details that can be issued out on request.

The written correspondence received on 28.09.2023 stated that C2I would operate an 'on-call' procedure at the children's home such that – in case of an emergency – contact could be made with C2I 24 hours per day.

3.0 - Parking and Access Layout

The side driveway that provides access from Green Lane through to the rear parking area measures between 2.0 and 2.2 metres in width.

To reiterate, this layout is already established. Previous residential dwellings at this site have utilised this layout; no changes to it are proposed in this application. The children's home would continue to utilise this layout. It is anticipated that the peak time of vehicle movements at the site would be outside of normal 'rush hour' at 9.30AM, when staff shifts change.
