## NOTES

### Disclosable Pecuniary Interests

The duties to register, disclose and not to participate in respect of any matter in which a member has a Disclosable Pecuniary Interest are set out in Chapter 7 of the Localism Act 2011.

Disclosable pecuniary interests are defined in the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 as follows –

<u>Interest</u>	<u>Prescribed description</u>
Employment, office, trade, profession or vocation	Any employment, office, trade, profession or vocation carried on for profit or gain.
Sponsorship	Any payment or provision of any other financial benefit (other than from the Council) made or provided within the previous 12 months (up to and including the date of notification of the interest) in respect of any expenses incurred by you carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.
Contracts	Any contract which is made between you, your spouse or civil partner or person with whom you are living as a spouse or civil partner (or a body in which you or they have a beneficial interest) and the Council (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged
Land	Any beneficial interest in land which is within the Council's area.  For this purpose "land" includes an easement, servitude, interest or right in or over land which does not carry with it a right for you, your spouse, civil partner or person with whom you are living as a spouse or civil partner (alone or jointly with another) to occupy the land or to receive income.
Licences	Any licence (alone or jointly with others) to occupy land in the Council's area for a month or longer.
Corporate tenancies	Any tenancy where (to your knowledge) – (a) the landlord is the Council; and (b) the tenant is a body in which you, your spouse or civil partner or a person you are living with as a spouse or civil partner has a beneficial interest
Securities	Any beneficial interest in securities of a body where – (a) that body (to your knowledge) has a place of business or land in the Council's area and

(b) either –

- i. The total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
- ii. If the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, your spouse or civil partner or person with whom you are living as a spouse or civil partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

For this purpose, “securities” means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

NOTE: the requirements in respect of the registration and disclosure of Disclosable Pecuniary Interests and withdrawing from participating in respect of any matter where you have a Disclosable Pecuniary Interest apply to your interests and those of your spouse or civil partner or person with whom you are living as a spouse or civil partner where you are aware of their interest.

1.	From Mr Davis to the Leader of the Council and Cabinet Member for Regeneration	My question to the Cabinet is why aren't local councillors and MPs, DBS checked? They are at the front line of our community and a majority of them work with children and vulnerable adults.
	<b>Response:</b>	
	Candidates standing for election in local government elections or parliamentary elections are not required to be DBS checked to validate their candidacy or to take up office if successful. Questions about the law should be directed to the city MP.	
2.	From Mr Mahoney to the Deputy Leader of the Council and Cabinet Member for Resources	Fix my street app is unfit for purpose. I thought the idea of this app was that people can report a problem and it gets directed to the relevant department, so why is it when reporting a problem is it ok to receive an email back saying this is GCH property rather than pass this report to GCH?
	<b>Response:</b>	
	As Gloucester City Homes (GCH) are a separate organisation to Gloucester City Council, to comply with the General Data Protection Regulations (GDPR) we are unable to share personal data (such as contact details) with them without the resident's explicit consent. Prior to submitting a request on FixMyStreet there is a notification advising that to enable the report to be progressed, your personal details need to be shared within Gloucester City Council, however, this does not permit us to share the information any further.	
	This means that while we can notify a customer if an issue pertains to GCH land or property, we are unable to automatically redirect their report to them and can only provide the relevant contact details for them to contact them directly.	
3.	From Mr Mahoney to the Cabinet Member for Environment	As a member of the public I would get fined for dropping litter, so why is it ok for the bin men to

		drop litter when collecting and not picking it up? It makes our streets untidy and messy.
<b>Response:</b>		
<p>The difference between these two scenarios would be that a member of the public would be likely to be fined for dropping litter deliberately, whereas our waste and refuse operatives would likely have dropped litter accidentally.</p> <p>We do ask our crews to be as careful as possible, while carrying out a physically demanding job at speed. We monitor standards regularly and I will soon be accompanying the Waste, Recycling and Street Scene manager on a KPI audit.</p>		
4.	From Mr Mahoney to the Cabinet Member for Environment	Green bin and recycling - as council tax has gone up and we are in a cost of living crisis wouldn't it be right to stop charges for the green bin and also, now DEFRA has said all recycling can be mixed, to provide all residents with a brown wheelie bin for recycling rather than the green boxes that get blown around in the wind and litter being blown out if the boxes again creating the rubbish to be blown out of the boxes and making a mess?
<b>Response:</b>		
<p>To drop the green waste bin charge altogether would lose the council a significant amount of money, and would need service reductions to be made to other services, or income to be generated, to pay for what is essentially a discretionary service. I do not believe it would be the best use of taxpayer money to do this.</p> <p>With regards to recycling, councils already have the ability to deliver recycling how we want to, but in our case what we lack is the equipment and resources to do this. Changing to a single bin with all recycling mixed in would require a significant capital outlay in new bins, lorries and changes at the depot, and would also need to comply with any overarching government directives. This is something we will be looking at as resources allow.</p> <p>Our current recycling is very high quality due to kerbside sorting, and we do perform well on recycling rates when compared to our nearest statistical neighbours.</p>		
5.	From Mr Redgewell to the Deputy Leader of the Council and Cabinet Member for Resources	<p>With ongoing work at Gloucester Transport hub, which we welcome, and Deep cleaning and plans to repair the bus departure doors information screens, there is a need to make clear walking routes between the Transport hub and the Railway station at Gloucester central Railway station, but real issues we are concerned about is the marketing plan for the café, which show it is being marked by an estate agent. But we still have no notices that the buffet cafe is to let. Some any investment in the cafe is only open to those who contact the estate agents.</p> <p>Can we not have a press release and/or a sign to market the cafe is to let?</p>

		<p>Similar to other Railway stations and bus and coach station in south west England, Gloucestershire County Council, the Transport Authority, is marketing the buffet cafe to all Transport catering company's; will Gloucester City Council look at a similar marketing campaign, as passengers require refreshments facilities at the Transport hub and interchange with the Railway station walkway is reopened?</p>
<p><b>Response:</b></p>		
<p>We have marketed this as a property transaction for a lease. We have not tendered it as a contract like other service providers. It is on the market currently and we have received a number of proposals, with the closing date on Friday 19<sup>th</sup> July. We will make a decision on a suitable provision after that date.</p>		
<p>6.</p>	<p>From Mr Redgewell to the Leader of the Council and Cabinet Member for Regeneration</p>	<p>With a new government in London and the need for more city Region government, what discussions are Gloucester City Council having with Tewkesbury Borough Council, Cheltenham Borough Council, Gloucestershire County Council and Western Gateway Partnership and Transport Board about inward investment in Regeneration of the city Region in Housing land, Regeneration of the city of Gloucester urban area, planning and Transport and Highways, and a Devolution deal for Gloucester and the wider Region?</p>
<p><b>Response:</b></p>		
<p>Cheltenham Borough Council, Tewkesbury Borough Council and the City Council undertake joint planning through the development of the emerging Local Plan for all three councils – through the Joint Strategic and Local Plan. This is a formal arrangement, and includes the County Council as a key stakeholder. Once completed, this plan will set out the future locations of growth together with the required supporting infrastructure, from 2023 to 2043. The first stage of consultation on this Plan was held earlier this year.</p>		
<p>We engage with a range of stakeholders, for example Homes England, the Ministry for Housing, Communities and Local Government (was Department for Levelling Up, Housing and Communities), and the County Council to attract grant funding for regeneration projects. Recent examples include the University of Gloucestershire City Campus, The Forum and Greyfriars Regeneration (all successful Levelling Up Bids), the Transport Hub (GFirst LEP grant funding) and the ongoing works at the Gloucester Train Station (GFirst LEP grant funding).</p>		
<p>With regards devolution, the then leader of the City Council submitted a letter of support to Gloucestershire County Council’s bid for a devolution deal prior to the May 2024 local elections.</p>		
<p>We are waiting for the King’s Speech, which should give us a clearer understanding of the future direction of the new government, and the opportunity and threats this may pose for Gloucester City Council.</p>

1.	From Councillor S. Chambers to the Cabinet Member for Housing	I note that you currently work as Homeseeker plus coordinator at Tewkesbury borough council and the Homeseeker policy is one of your responsibilities within your cabinet portfolio here at Gloucester. How do you intend on managing this conflict of interest?
	<b>Response:</b>	
	On the 1st May 2024 I changed jobs and the homeseekerplus coordinator role and responsibilities reverted back to the lead authority which is the Forest of Dean District Council. I no longer have any dealings with the role and therefore no conflict of interest.	
2.	From Councillor S. Chambers to Cabinet Member for Environment	Following the report of another fly tip on Naas Lane this morning will the cabinet member look at installing temporary cameras to help catch and deter the culprits.
	<b>Response:</b>	
	The Enviro-crime team currently consists of only two officers, so they must prioritise their time and resources to address problems that are most likely to deliver results and reduce waste-related issues. Cameras can effectively capture fly-tipping offenses, but they require significant resources to install and analyse.	
	We use a third-party contractor to relocate cameras, which incurs substantial costs. Once an offence is recorded, it takes several hours for an officer to review the footage and identify the offender.	
	With just two officers, this is not always feasible for every fly-tipping incident, which is why prioritisation is necessary. If the problem persists on Naas Lane and the team considers CCTV a viable solution, a camera can be temporarily installed there. Please continue to report incidences of fly-tipping to the council.	
3.	From Councillor Pullen to the Leader of the Council and Cabinet Member for Regeneration	Could the Leader please give an update on progress towards the proposed sale of Gloucestershire Airport?
	<b>Response:</b>	

	<p>The Liberal Democrat manifesto ‘Putting the Heart back into Gloucester’ on which we won the local elections states that the council will “continue support for Gloucestershire Airport to remain an important aviation and high-tech business hub that provides for locally based skilled employment”.</p> <p>The administration has been considering the option to put the airport up for sale or not and we are now carrying our investigations into the pros and cons in order to make such a decision, that has included a visit to the airport to meet the senior management.</p>	
4.	From Councillor Pullen to the Cabinet Member for Community Engagement	It is understood that The Gateway (Customer Services) is to move to the Eastgate Centre. Exactly where will it be located, how will the public access the service and what days and times will it be open?
<b>Response:</b>		
<p>A members update was issued on 10 July 2024 to confirm that Gloucester City Council’s appointment area moved from The Gateway to Eastgate Shopping Centre earlier this month.</p> <p>Pre-booked face-to-face appointments for council services are being held at the new facility located on the first floor of the Eastgate shopping centre, opposite the main council offices, from Monday 15 July.</p> <p>The Gateway previously allowed residents to arrange to see staff if their query could not be resolved over the phone or by email. Residents will be informed of the new location should they require a face-to-face appointment.</p> <p>The new appointment area will offer the same service as The Gateway. The space will include a dedicated appointment area with two private rooms and a bank of hot desks. There will be pre-bookable appointments available initially on a Tuesday morning and Thursday afternoon with some flexibility for services to book appointments outside of these times, should they be required.</p> <p>The move will make it easier for those residents that require a face-to-face appointment with closer parking, lift access, and a more central location nearer public transport hubs, as well as making it easier for officers to support more complex customer queries, and is set to save taxpayers around £80,000 annually in reduced running costs.</p> <p>Since the pandemic, the appointment system brought in to reduce waiting times has seen the need for a large appointment area fall, as demand for face-to-face appointments has dropped sharply.</p> <p>The majority of residents who contact the council say they prefer to do it over the phone, online or by email, with just 81 face to face appointments being booked out of a potential 600 available slots since May 2023, and only 68 appointments being attended.</p> <p>The change has also improved the service for both staff and residents, with the number of reports of abuse towards staff reduced, and improved customer confidentiality.</p> <p>The public will continue to have access to a direct dial free telephone in the lobby area of The Gateway at this time whilst a telephone pod for the new location is being installed. This new freephone will be located under the stairs on the ground floor of Eastgate shopping centre, to provide a level of privacy</p>		

	<p>for those using it. This telephone will enable the public to access services during the times of Mon, Tues, Thurs, and Fri 9am – 5pm and Wed 10am – 5pm.</p> <p>The new appointment area will be signposted within the shopping centre.</p>	
5.	<p>From Councillor A. Chambers to the Deputy Leader of the Council and Cabinet Member for Resources</p>	<p>Can the City council immediately release the missing accounts that they have held from the public for every year that the accounts have not been made public? The public have a right to know the financial position.</p>
<p><b>Response:</b></p> <p>The financial position of the Council has been reported quarterly to O&amp;S and the Cabinet via the Financial Monitoring and Outturn reports, most recently at the Overview &amp; Scrutiny Meeting of 1<sup>st</sup> July 2024. Although previously promised before the local elections, the knock-on effect of the cyber-attack has led to a significant quantum of data having to be re-populated into the financial systems to allow for the completion of the formal financial statements of the Council for the years 2022-23 and 2023-24. The 2022-23 financial statements will be published for the September A&amp;G Committee with the 2023-24 to follow.</p>		
6.	<p>From Councillor A. Chambers to the Deputy Leader of the Council and Cabinet Member for Resources</p>	<p>Can the city council immediately disclose as public interest exactly how much of tax payers money was lost at the club at Tuffley?:</p> <ol style="list-style-type: none"> <li>1. Lost/unpaid rent</li> <li>2. Lost utilities</li> <li>3. Damages to the building which require works</li> <li>4. Required roof repairs</li> <li>5. Legal costs</li> <li>6. Cost of lost rent payments of the building being empty for last year</li> <li>7. <p><b>Response:</b></p> <ol style="list-style-type: none"> <li>1. Lost/unpaid rent: £43,388.15</li> <li>2. Lost utilities: £62,330.83</li> <li>3. Damages to the building which require works: £5,000 approximately</li> <li>4. Required roof repairs: £25,000-£50,000 (to be confirmed once a full specification has been received)</li> <li>5. Lost council tax payments for the duration and since the building has been empty. £0</li> </ol> <p>No Council tax is payable on a commercial premises.</p> <p>The tenant received full Small Business Rate Relief until 31/03/23. Then the ratable value increased and he had a charge to pay, although he didn't make any payments. The charge would have been £600 for the previous financial year. This was then calculated pro-rata when he vacated in August 2023. The balance</p>		

	was reduced to £221.31. The Council obtained a liability order from the Magistrates Court for this debt which added £60 costs.	
8.	From Councillor Millard to the Cabinet Member for Culture and Leisure	Does the Cabinet Member for Culture and Leisure agree that the cost of entry to the recent Tall Ships Festival was far too expensive for many families in Gloucester and prevented them from attending this event?
<b>Response:</b>		
<p>Some of the feedback received by the council suggests that the cost of entry proved too expensive for some people.</p> <p>We are living in a cost-of-living crisis which, alongside the rise in prices for consumers, means that providing these large-scale events for free or minimal entry price becomes increasingly difficult. Since the pandemic, event infrastructure costs have increased exponentially, whilst funding and sponsorship have at best remained at a standstill. Many festivals and large-scale events across the country are being cancelled with organisers ceasing operations entirely.</p> <p>Tall Ships Festival has very high base costs to run even a basic version of the event and without a financial foundation of statutory, charitable, or private funding, it would have been irresponsible to run the event without a method for recouping costs as bringing the production of the event in-house for the first time meant that Gloucester City Council was in effect the event's underwriter. The production timescale was short, so alternative funding sources were not available to offset costs.</p> <p>To run the event at all, Officers determined that paid ticketed entry was the only possible model that could cover event overheads. It is important to note that this paid entry model is not a money-making exercise but a loss-minimising one. This is not an entirely new model – organisers of Tall Ships Festival charged for entry on previous occasions, sometimes just for access to ships, sometimes for access to the site.</p> <p>Prices sought to balance affordability with income generation that could meet the cost of staging the event. It should be noted that children aged six and below could attend for free, meaning families with young children could pay as little as £14 for entry. In comparison to other day festivals and family experiences, Tall Ships Festival's ticket spread was priced as follows:</p> <ul style="list-style-type: none"> <li>• PuttPutt Social Gloucester – 9 holes of crazy golf for 1 adult and 3 kids: £24.50</li> <li>• McDonalds - order of 2 happy meals and 2 big macs delivered: £25.92</li> <li>• Three Counties Food Festival – basic day family ticket (sessions in addition): £31</li> <li>• Tall Ships Festival – starting family price (1 adult, 3 U18s (not inc. U6s) – ships additional): £32.30</li> <li>• Nathan Evans (Tall Ships headliner) at The Garage – 4 tickets to single gig: £60</li> <li>• 2000 Trees Festival (Cheltenham) – 4 day tickets (1 adult, 3 U13s): £95</li> <li>• App Fest (Tewkesbury) – family day ticket: £100</li> </ul> <p>There is much to learn from the Council's first experience of producing this event in house and officers are preparing a detailed analysis including customer and</p>		

	<p>resident feedback to provide recommendations on running future similar events. It is right that we always look to improve, and we can assume that any price will always be a barrier to some. To address this, the culture team are actively looking at targeted access schemes, which could include offering free tickets through community groups and charities, and discounted tickets through schemes such as Blue Light Card, NUS and Days Out Guide. These will be announced as they launch. The next Tall Ships event/programmes will be held in 2027 to celebrate the bicentenary of Gloucester Docks. This longer production period will enable the Council to diversify the bicentenary's funding.</p>	
9.	<p>From Councillor O'Donnell to the Cabinet Member for Culture and Leisure</p>	<p>How is the disabled parks motion progressing that the independents moved for all Gloucester City Parks to be all inclusive by 2026?</p>
	<p><b>Response:</b></p> <p>The motion referred to by Cllr O'Donnell was passed in March this year and requested the city council to establish a city-wide play strategy which pledges to provide large, well equipped, and accessible play areas for all children of all abilities by December 2026, with a commitment that inclusivity be at the heart of all future playground design.</p> <p>The Council has committed to establishing this play strategy by December 2026 - it will form part of the new Open Spaces Strategy which is due to be adopted in 2026 after the current one ends. In the meantime, any new play areas due for development before December 2026 will incorporate elements of inclusivity.</p> <p>Development of the new Open Spaces Strategy, which will include this play strategy, will commence in 2025 – it's an extensive piece of work and will involve a review of all our existing policies and procedures.</p>	
10.	<p>From Councillor James to the Cabinet Member for Environment</p>	<p>Why are Council contractors UBICO unable to produce a weed spraying schedule for 2024, despite this being available in previous years?</p>
	<p><b>Response:</b></p> <p>We have never been able to produce an accurate weed spraying schedule because the service is weather dependent. Normally we would carry out the first spray at the end of March/early April, but the wet and windy weather in both April and May prevented that happening this year. Spraying commenced in May and Ubico were making good progress with some staff working overtime at weekends.</p> <p>Unfortunately there was some more rain at the start of July so this delayed things slightly again.</p> <p>I will be pushing to get the weeds cleared and the streets looking tidy again as soon as possible.</p>	
11.	<p>From Councillor Bell to the Cabinet Member for Community Engagement</p>	<p>In Tuffley &amp; Grange, young and old struggle to get doctors appointments and have to travel far to get medical access and treatment. Can Gloucester city council look into discussions with Gloucestershire County Council, NHS and other relevant stake holders to consider a new doctor's surgery at Tuffley &amp; Grange?</p>
	<p><b>Response:</b></p> <p>The City Council does not have direct influence on the provision of additional GP services however, we will ask that this matter is discussed at the September</p>	

	<p>Integrated Locality Partnership Meeting (ILPs). Gloucester ILP is a partnership comprising of the City Council, NHS, Voluntary Community and Social Enterprise (VCSE) sector, housing, and communities, aimed at bringing services together and planning how they are delivered to local populations.</p> <p>Just to note: Aspen Medical Practice at 38 Warwick Avenue, Grange, GL4 0SL, is currently accepting new patients and residents are asked to contact them at 01452 337733 for appointments.</p>	
12.	From Councillor Marshall to the Cabinet Member for Environment	Does the Cabinet Member for Environment agree that the fly tipping in Barton and Tredworth is completely out of control?
	<b>Response:</b>	
	<p>Although Barton and Tredworth has the highest reported fly-tipping issues among all wards, the problem remains manageable and is definitely not 'out of control.' Several factors explain the high number of incidents: 95% of the properties in the ward lack off-road parking facilities and approximately 20% of the properties do not have a frontage, opening directly onto the pavement. This means that storing excess waste on the property is not straightforward for many households in the ward.</p> <p>Compared to other wards, Barton and Tredworth has the fewest cars per household, making residents less likely to transport excess waste to the Household Recycling Centre. The take up for this trial approach from rough sleepers has provided useful data to measure whether the offer of open access accommodation may in the future provide positive outcomes for individuals alongside the continuing Severe Weather Emergency Protocol (SWEP) accommodation that is provided during periods of severe weather including extreme cold winter weather. The information is being reviewed and further options considered, including the development of plans to establish instant access provision in a broader range of accommodation types (such as shared properties or single unit properties).</p> <p>Where individuals sleeping rough are considered to be in priority need (as set out in the relevant legislation) the council has obligations to provide accommodation and therefore these individuals will have been offered accommodation by the council.</p> <p>The council continues to provide a range of support and other interventions to assist rough sleepers access housing opportunities and move away from the street, and ending rough sleeping remains a key priority for the council moving forward.</p>	
23.	<p>From Councillor Bell to the Cabinet Member for Planning</p>	<p>The Whaddon housing development is causing great concern with regards to the planning aspect to Tuffley &amp; Grange. We as residents are against it. The initial mapping exercise to complete this project is complete but the mapping is continually updated as new information is provided such as adopted land on new developments.</p> <p>The mapping focuses on areas which require ground maintenance services including trees, hedges, bushes and grass. It identifies the cutting or maintenance schedules for each area mapped.</p> <p>Currently the information is available to Customer Services, Ubico and the Open Spaces Team. <b>Response:</b>		
The Council's position on this hasn't changed since this was raised in the budget review in February. The Council has no current plans to outsource the running of cultural venues like Gloucester Guildhall and Blackfriars Priory to external providers. The Council continues to follow the recommendations of the Culture and Leisure Management Options Appraisal brought to Cabinet in May 2022 that		

recommended culture services should remain an in-house service, and that leisure services should be tendered out to a multi-site operator.

Whilst running cultural venues results in a cost to the Council, this should not be viewed as a loss. The Council makes a budget allowance to invest in culture in the city to make it a great place to live, work and study, and enrich people's lives.

This investment in culture results in:

- 50+ directly employed jobs
- support for many cultural organisations and creative projects in the city
- 1000+ events either supported and/or directly delivered
- over 750,000 objects managed in the city's museum collection
- hundreds of thousands of audience members and participants in cultural activity with all of the wellbeing, mental health and community cohesion benefit that activity brings.
- economic impact. Nationally, every pound invested in culture results in over £5 delivered back to the wider economy, through hospitality, accommodation, tourism and other sectors.
- additional government investment in and statutory funding for Gloucester, for example
  - Successful bid to Levelling Up Round 3 for the Greyfriars Quarter which has a cultural focus
  - Gloucester's status as an Arts Council England Priority Place, increasing the number of National Portfolio Organisations in the city from 1 to 4 from April 2023. In 2023-24, the total value of grants awarded by Arts Council England to individuals and organisations in Gloucester was £2,517,311.

In fact, Blackfriars Priory is currently on a positive financial trajectory in line with its business plan and is projected to make a net profit by 2027-28. In addition to this, the venue is owned by English Heritage and leased to the Council, the terms of which prevent it from being sub-let to another entity.

Gloucester Guildhall is an Arts Council England (ACE) National Portfolio Organisation (NPO), receiving annual funding of £250,000, which is not transferable to another provider. The new business plan for the Guildhall brought to Cabinet yesterday sets out our goals for the next 5 years, the first of which is to reduce the percentage of turnover provided by GCC as subsidy. The venue makes a significant contribution to the city's cultural sector and our communities, especially since becoming an NPO, which supports the development of participation and engagement activities for families with young children, young people aged 18-25, over 50s and displaced communities.

30.	From Councillor Bell to the Cabinet Member for Environment	Tuffley & Grange needs to be provided a weed & litter pick time table. Residents are annoyed at the grass and weed work that is adhoc. Strimmers cut the grass and leave large sections for the lawn mower and vice versa. It means the grass areas never look tidy. They are either strimmed but not lawn mowed or lawn mowed and not strimmed. Please could you provide such a time table?
<b>Response:</b>		
Grass cutting is carried out by the ride on mowers on a 15-20 day cycle and strimming only takes place twice a year. This is in accordance with the contract. For this reason, cutting and strimming will never be perfectly synchronised.		

	<p>Litter picking takes place once a fortnight in most areas. In areas of higher footfall, the frequency is increased according to need and available resource.</p> <p>Weed spraying is underway in the city and crews are making good progress now. This service is weather dependant and cannot take place during wet or windy weather which is why any schedule would not be accurate and is not provided. The service did not start until June this year due to the adverse weather conditions in April and May. If residents wish to know whether their area has been sprayed this information is available.</p>	
31.	<p>From Councillor Gravells Deputy Leader of the Council and Cabinet Member for Resources</p>	<p>Earlier this year I was told: “The current parking orders for our car parks only allow for vehicles to be unoccupied..... to enable motorhomes to be occupied in our car parks overnight we would need to change permissions from a car park to a campsite and this would require additional planning approvals and a change to the car park orders”.</p> <p>In the light of this will the new Cabinet member be prepared please to review that ruling, with a view to making it easier and more welcoming for visitors in motorhomes to visit Gloucester and stay overnight for a few days to visit not just the city, but the great neighbouring towns and villages right here on our doorstep. 	<p><b>Response:</b> The new administration has been supportive of the Greyfriars Regeneration Project (which includes a new market) since its inception.</p> <p>As you will recall, Gloucester City Council were ‘provisionally awarded’ levelling up grant funding from the Department for Levelling Up, Communities and Housing (now Ministry of Housing, Communities and Local Government) for regeneration works in the Greyfriars Quarter (including the development of a new market) in November 2023. However, those funds were not confirmed until late May 2024. Subsequently, the pre-election period associated with the national election has further prolonged the award.</p> <p>This regeneration project is heavily reliant on grant funding, and without confirmation of funding the scheme has not advanced at the pace we had hoped. Now the general election is over we are engaging with officials at Ministry of</p>	

	Housing, Communities and Local Government. We hope to be in a position soon to confirm a timetable for delivery, which will include a plan for stakeholder engagement.	
33.	From Councillor Patel to the Deputy Leader of the Council and Cabinet Member for Resources	Have the council's accounts for 2021/2022 been signed off yet. If not can you provide a firm timeframe please?
	<b>Response:</b>	
	No – the financial statements for 2021/2022 have been published and are available on the Council's website. Auditor sign off of the accounts is subject to the backstop agreement which was delayed as a result of the recent national election. The backstop agreement proposed a September deadline, however this was subject to parliamentary approval and was dropped as a result of the dissolution of Parliament in May. Whether the backstop agreement gets reinstated is now subject to the new Government's plans, and we are working with our external auditors to resolve this situation.

	We will always work hard to find savings and increase council income. With respect to council tax rates however, our biggest obstacle is the Local Government Financial Settlement which assumes Councils raise Council Tax to the maximum allowed. Failure to do so would reduce the Council's core spending power and limit the funds available to deliver services to residents in both the current and future years. This would ultimately cost local taxpayers more.	
	The Council operates a Council Tax support scheme for those residents who need help paying their Council Tax.	
35.	From Councillor Bell to the Cabinet Member for Environment	I've had emails already about dog bins in Emerald Close. What will the city council do about the dog bin issue where bins are either full too quickly or not enough bins servicing the areas. Can an audit of bins including dog bins be carried out in Tuffley Grange as it's causing upset and concern for many residents?
	<b>Response:</b>	
	This is already underway. Our litter and dog bins in the city are digitally mapped now, and Ubico staff are able to record whether the bin is half full, full or overflowing on emptying. Ubico will be able to adjust the emptying frequencies accordingly. This level of information will allow better use of resource and allow us to remove or move bins which are not being used to more suitable locations. Once the digital integration programme is complete Council staff will have access to real time information from the Ubico system.

I anticipate that a draft plan will be approved by Cabinet for public consultation in the Autumn, with the Overview and Scrutiny Committee invited to comment on the plan as part of the formal consultation process before Council is asked to approve the plan in the new year. This follows a similar timeline to previous Council Plans.</p>
