## **Disclosable Pecuniary Interests**

The duties to register, disclose and not to participate in respect of any matter in which a member has a Disclosable Pecuniary Interest are set out in Chapter 7 of the Localism Act 2011.

Disclosable pecuniary interests are defined in the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 as follows -

Interest Prescribed description

Employment, office, trade, profession or

vocation

Any employment, office, trade, profession or vocation carried on for profit or gain.

**Sponsorship** 

Any payment or provision of any other financial benefit (other than from the Council) made or provided within the previous 12 months (up to and including the date of notification of the interest) in respect of any expenses incurred by you carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

Contracts Any contract which is made between you, your spouse or civil

> partner or person with whom you are living as a spouse or civil partner (or a body in which you or they have a beneficial

interest) and the Council

(a) under which goods or services are to be provided or works are to be executed: and

(b) which has not been fully discharged

Any beneficial interest in land which is within the Council's

area.

For this purpose "land" includes an easement, servitude, interest or right in or over land which does not carry with it a right for you, your spouse, civil partner or person with whom you are living as a spouse or civil partner (alone or jointly with

another) to occupy the land or to receive income.

Any licence (alone or jointly with others) to occupy land in the

Council's area for a month or longer.

Corporate tenancies Any tenancy where (to your knowledge) –

(a) the landlord is the Council; and

(b) the tenant is a body in which you, your spouse or civil partner or a person you are living with as a spouse or civil

partner has a beneficial interest

Any beneficial interest in securities of a body where –

(a) that body (to your knowledge) has a place of business or land in the Council's area and

(b) either -

The total nominal value of the securities exceeds £25.000 or one hundredth of the total issued share

Land

Licences

Securities

- capital of that body; or
- ii. If the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, your spouse or civil partner or person with whom you are living as a spouse or civil partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

For this purpose, "securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.

NOTE: the requirements in respect of the registration and disclosure of Disclosable Pecuniary Interests and withdrawing from participating in respect of any matter where you have a Disclosable Pecuniary Interest apply to your interests and those of your spouse or civil partner or person with whom you are living as a spouse or civil partner where you are aware of their interest.

84.1 There were no declarations of interest.

## 85. ADMISSION OF HONORARY FREEMAN

85.1 Councillor Morgan moved and Councillor Pullen seconded the following motion:

That pursuant to Section 249 of the Local Government Act 1972, Mr Robin Morris be admitted as an Honorary Freeman of the City of Gloucester in recognition of his significant contribution to the character and life of the City through his many years of active involvement in the protection and preservation of Gloucester's unique heritage.

85.2 Councillor Morgan praised the outstanding contribution Mr Morris had made to the City over a period of fifty years noting that he had been a founding

member of Gloucester Civic Trust as well as its Chair for forty years. Councillor Morgan also pointed to Mr. Morris' position as Senior Officer of the Order of St. John and his receiving of the award of MBE as further testament to his qualifications for receiving the award of Honorary Freeman. On behalf of the people of Gloucester, Councillor Morgan thanked Mr Morris for his significant contribution to the character and life of the City of Gloucester.

- 85.3 In seconding the motion, Councillor Pullen recounted the port status of Gloucester being bestowed upon it in 1580 and that Mr. Morris had organised the 400<sup>th</sup> anniversary of this event through the Gloucester Civic Trust which had been an integral part of regenerating the Docks area of the City. Councillor Pullen paid tribute to his work over many years in his many and varied roles.
- 85.4 Councillor Hilton spoke in favour of the motion and stated that it was a thoroughly deserved award. He stated his belief that the Westgate area of the City would have been different today were it not for Mr. Morris' endeavours in terms of, not only his work to regenerate the area but to also preserve its historic nature.
- 85.5 Mr. Morris addressed Council expressing his gratitude for receiving the honour of the award. He thanked Members for their kind words and implored all to continue to preserve Gloucester's heritage.
- 85.6 **RESOLVED that:-** pursuant to Section 249 of the Local Government Act 1972, Mr Robin Morris be admitted as an Honorary Freeman of the City of Gloucester in recognition of his significant contribution to the character and life of the City through his many years of active involvement in the protection and preservation of Gloucester's unique heritage.

#### 86. FREEDOM OF ENTRY

86.1 Councillor Gravells moved and Councillor Hilton seconded the following motion:

That pursuant to Section 249 of the Local Government Act 1972, the Gloucester Branch of the Royal British Legion be granted Freedom of Entry to the City of Gloucester in recognition of their significant contribution and eminent service to the City.

- 86.2 Councillor Gravells praised the good work of the Royal British Legion (RBL) in Gloucester and particularly recalled the good work of a number of key individuals. He paid tribute to the organisers of the annual Poppy Appeal and noted that in this, the centenary year of RBL the Gloucester branch aimed to raise £100k. Additionally, Councillor Gravells encouraged Members to become members of RBL themselves.
- 86.3 Councillor Hilton noted the educational work RBL had undertaken over many years and that awarding the Freedom of the City to RBL was the right thing to do, noting that numerous other areas had made the same award.

- 86.4 Councillor Pullen noted that the founding principles of the RBL and support for veterans still applied today and pointed to the fact that the organisation continued to make a significant contribution to the City.
- 86.5 Councillor Chambers-Dubus stated that it was a well deserved award. She noted that RBL also educated people how important how support for veterans was and how peace could be achieved.
- 86.6 On behalf of the Gloucester branch of RBL, Mr. Garry Mills spoke to thank Members for their support. He recalled his work over numerous years working with Members and the wider community. Mr. Mills reiterated that the work of RBL was both to support those who had been involved in conflict and to move away from conflict in principle.

#### 87. MINUTES

87.1 The minutes of the meetings held on 24 February 2022 were approved and signed by the Mayor as a correct record.

#### 88. DECLARATIONS OF INTEREST

88.1 There were no declarations of interest.

#### 89. CALL OVER

- 89.1 The Mayor invited Members to indicate whether they wished to reserve agenda items 9, 10, 11, and 12 for discussion. There was no indication that any of these items were for discussion.
- 89.2 Councillor Norman (Deputy Leader of the Council) moved and Councillor Cook (Leader of the Council) seconded the Treasury Management Strategy 2022/23 be approved.

#### 89.3 **RESOLVED** that

## 90. PUBLIC QUESTION TIME (15 MINUTES)

90.1 A Gloucester resident asked the following question:

How can you justify your commitment to tackling climate change by spending an extra £100m, causing exposure to immediate particular matter impacting lungs, brains, hearts, eyes locally in the context of nationally estimated deaths of 40000 a year and what are the levels of extra carbon emissions (figures required please scope 1-3); this spending on new roads in the light of your alleged active travel policy for walking and cycling is five times the spend on cycling of £20m, segregated cycling lanes and living streets worth walking down can cut the under three miles commute by 50% of those travelling to work. Building road means more motorised traffic and pollution and CO2 plus electric vehicles still emit PMs via break dust and tyre wear?

90.2 Councillor Cook noted that responsibility with highways and therefore road building sat with the County Council and acknowledged that the City Council

had responsibility for monitoring air pollution – the threshold for action having not been met. He reaffirmed the administration's commitment to acting on climate change and suggested the questioner raise this matter with the County Council.

## 91. PETITIONS AND DEPUTATIONS (15 MINUTES)

91.1 There were no petitions or deputations.

#### 92. ANNOUNCEMENTS

## **Leader of the Council**

92.1 The Leader of the Council, Councillor Cook informed Members that the Council had been awarded an £85k grant to install two new changing place toilets in the city centre which would be specifically for disabled access. One would be situated at the Quays and another at the Museum of Gloucester.

## **Members of the Cabinet**

92.2 The Cabinet Member for Planning and Housing Strategy, Councillor S. Chambers announced that 86 new homes had recently come online in Quedgeley Field Court, with 25% being s.106 homes. (25% shared ownership and 75% affordable rent). The Housing project and strategy team had worked in partnership with Sanctuary Homes and occupational therapists to ensure that 17 of these homes were built to meet accessible and adaptable needs of residents and would be let via the Homeseekers register to households in need of this accommodation. Sanctuary recently commented that Gloucester City Council provided Sanctuary with an improved understanding of accessible and adaptable housing needs in Gloucester providing huge benefits to all.

#### 93. MEMBERS' QUESTION TIME

- 93.1 In respect of question 1, Councillor Hilton stated that Members had previously been assured by a previous Cabinet Members that there would be an exciting development on the former Sainsbury's site at Northgate Street and asked the Cabinet Member for Planning and Housing Strategy proposed to do to kick start the site. Councillor S. Chambers advised that proposals were yet to come forward but whatever was proposed, whether it be leisure, retail, entertainment or residential, would be considered.
- 93.2 With regard to question 2, Councillor Hilton how many servers had to be rebuilt and what was the budgetary cost. Councillor Norman advised that, at this stage, it was not possible to project figures. She further advised that some data provision had been moved from the previous council offices and, as such, were not on council premises and therefore these were not affected.
- 93.3 Councillor Pullen asked, in relation to question three, why checks could not be made regarding whether current investments had a Russian origin in light

- of Russia's recent invasion of Ukraine. Councillor Norman explained that Councillor Pullen's original question was in relation to procurement which would be taking place in the future but that she would liaise with the Director of Policy and Resources regarding whether any current services were in receipt of Russian investment.
- 93.4 In respect of question 4, Councillor Pullen asked whether the Council would write to all residents who did not pay Council Tax by direct debit to advise on how they could claim the Council Tax rebate offered by the Government. Councillor Norman advised that the council worked with local advice partnerships who disseminate such information and that a more detailed communication plan would be drawn up upon receiving finalised advice from central government.
- 93.5 Councillor Hyman asked if the Leader of the Council had asked Ubico if a vehicle could be provided for garden waste collection in narrow streets in his ward. Councillor Cook stated that discussions had taken place but that it would not be right to say garden waste would be collected from such properties when it was unlikely to be deliverable.
- 93.6 Councillor Castle asked how it could be ascertained how much could be delivered in terms of refuse collection from street bins when it was uncertain how many bins there were. Councillor Cook noted that the mapping exercise referred to in the original published answer examined open space. He advised that Ubico would continue such collections and would be monitored so that bins would not be overflowing.
- 93.7 In respect of question 8, Councillor Field asked if, given clothes banks were a 'hot-spot' for flytipping, now was the time to consider removing the clothes banks particularly given they were for a charity based in Wolverhampton. Councillor Cook replied that landlords could be contacted to examine whether they could remove them themselves.
- 93.8 Councillor Chambers-Dubus asked, following the removal of the commitment to not work with publications such as the Daily Mail and the Sun, where the Council drew the line between strong opinion and hate speech. In the absence of the Cabinet Member for Culture and Leisure, Councillor Lewis, Councillor Norman stated that, in a free society, everyone should be treated with dignity and respect. A free press also operated and some publications such as newspapers had different political viewpoints which were open to interpretation by all.
- 93.9 Regarding question 15, Councillor Hilton asked Councillor Norman when she expected an answer to whether the Council would receive funding for cyber recovery. Councillor Norman advised that there was not necessarily a set deadline and that a formal request would be submitted to the Department for Levelling Up, Housing and Communities via the Managing Director once a precise figure had been reached.
- 93.10 With regard to the sale of the Herbert, Kimberley and Philpotts warehouses, Councillor Hilton asked why a planning application had not yet been

received. Councillor Norman advised that officers were following this up with the prospective buyer and that they still intended to progress with an application. Officers were working with the prospective buyer to bring an application to the Planning Committee.

- 93.11 In respect of question 18, Councillor Hilton asked if Mod.Gov (the software which held records of previous meetings) would be available ahead of the Annual Meeting in May 2022. Councillor Norman advised that work was underway to transfer such software to a 'cloud' based model and that, whilst there was optimism this could be achieved, it was not possible to place a concrete timeframe on it.
- 93.12 With regard to the Uniform system, Councillor Hilton asked when this would be operational. Councillor Norman that a project plan was being progressed and that officers were working hard to bring it into operation as soon as was possible.
- 93.13 In regards, to the cyber incident, Councillor Hilton asked if there were sufficient funds to recover. Councillor Norman responded that, as there was no final figure as yet, this was not possible to determine at the present time.
- 93.14 In respect of question 22, Councillor Wilson asked is phase one of the cyber recovery was complete and whether it was a requisite that laptops be physically replaced. Councillor Norman advised that differing areas had differing timescales but that recovery was progressing well. She further advised that many laptops were coming towards the end of their useful life and would need to be replaced in any event.
- 93.15 With regard to question 23 and whether any individual had been deported under the Home Office's Rough Sleeping Support Service, Councillor S. Chambers advised that a written response would be provided to Councillor Wilson.
- 93.16 Councillor Sawyer asked, in respect of question 25, how, other than social media, the Council proposed to reach those without such means. Councillor Cook advised that the Council did as much as was possible and such details had regularly appeared in the press. Often, he further advised, Councillors were in a position to disseminate such information and that such incidences of missed collections were becoming fewer.

#### 98. NOTICES OF MOTION

98.1 Councillor Pullen proposed and Councillor Chambers-Dubus seconded the following motion:

"This council recognises the major impact the Covid 19 pandemic has had on Gloucester with virtually all areas in the city being affected. Many people have contracted the virus and too many have lost their lives with friends and families losing loved ones.

Health and welfare services have been pushed to the limit but have done a fantastic job in extremely difficult circumstances.

The business community has been severely hit with many local companies struggling to cope.

However, the resilience and determination of Gloucester people has shone through and there has been many excellent examples of people and organisations going that extra mile to help others.

The efforts of key workers have been phenomenal and along with our outstanding NHS staff they have continued to deliver essential services and their vital role in 4 looking after us. This has been despite often extreme and very challenging circumstances.

The city has also experienced a massive community spirit with local volunteers and community organisations looking after vulnerable people and those who were isolating, ensuring they had food and other essential supplies.

The Covid pandemic is not over yet and it may be still too early to call. However, it is time to start thinking about how Gloucester marks and remembers the huge impact that Covid has had on our city, the sacrifices people have made and the sterling community effort that took place in order to cope.

It would therefore be very appropriate to create a permanent and long lasting Covid Memorial to be placed in a prominent position in the city. The memorial would remember all those who lost their lives and be a fitting tribute to key workers in essential services and the phenomenal community effort that was made.

The memorial would tell the story of how the people of Gloucester coped with the Covid pandemic so that future generations could appreciate and understand the sacrifices that were made.

Gloucester City Council should take the lead in creating the memorial but should do so in partnership with the many appropriate organisations and interested parties in the city. This would ensure a structure that was created by and representative of a wide range of people communities and organisations.

#### Council resolves to:

- Take the lead in creating a lasting Covid Memorial to be sited in a prominent position in the City Centre.
- Design a fitting tribute that remembers those who lost their lives and recognises the immense contribution that key workers, volunteers and community organisations made during the crisis.
- Bring together a partnership of appropriate organisations and agencies to deliver the project and draw on their resources, skills and talents.

- Fully involve local people, communities and voluntary organisations."

The efforts of key workers have been phenomenal and along with our outstanding NHS staff they have continued to deliver essential services and their vital role in 4 looking after us. This has been despite often extreme and very challenging circumstances.

The city has also experienced a massive community spirit with local volunteers and community organisations looking after vulnerable people and those who were isolating, ensuring they had food and other essential supplies.

The Covid pandemic is not over yet and it may be still too early to call. However, it is time to start thinking about how Gloucester marks and remembers the huge impact that Covid has had on our city, the sacrifices people have made and the sterling community effort that took place in order to cope.

It would therefore be very appropriate to create a permanent and long lasting Covid Memorial to be placed in a prominent position in the city. The memorial would remember all those who lost their lives and be a fitting tribute to key workers in essential services and the phenomenal community effort that was made.

The memorial would tell the story of how the people of Gloucester coped with the Covid pandemic so that future generations could appreciate and understand the sacrifices that were made.

Gloucester City Council should take the lead in creating the memorial but should do so in partnership with the many appropriate organisations and interested parties in the city. This would ensure a structure that was created

by and representative of a wide range of people communities and organisations.
