Use of table and chairs or advertising boards on a highway will need a separate application to be made to the Licensing Team to request separate consent under the Highways Act 1980.

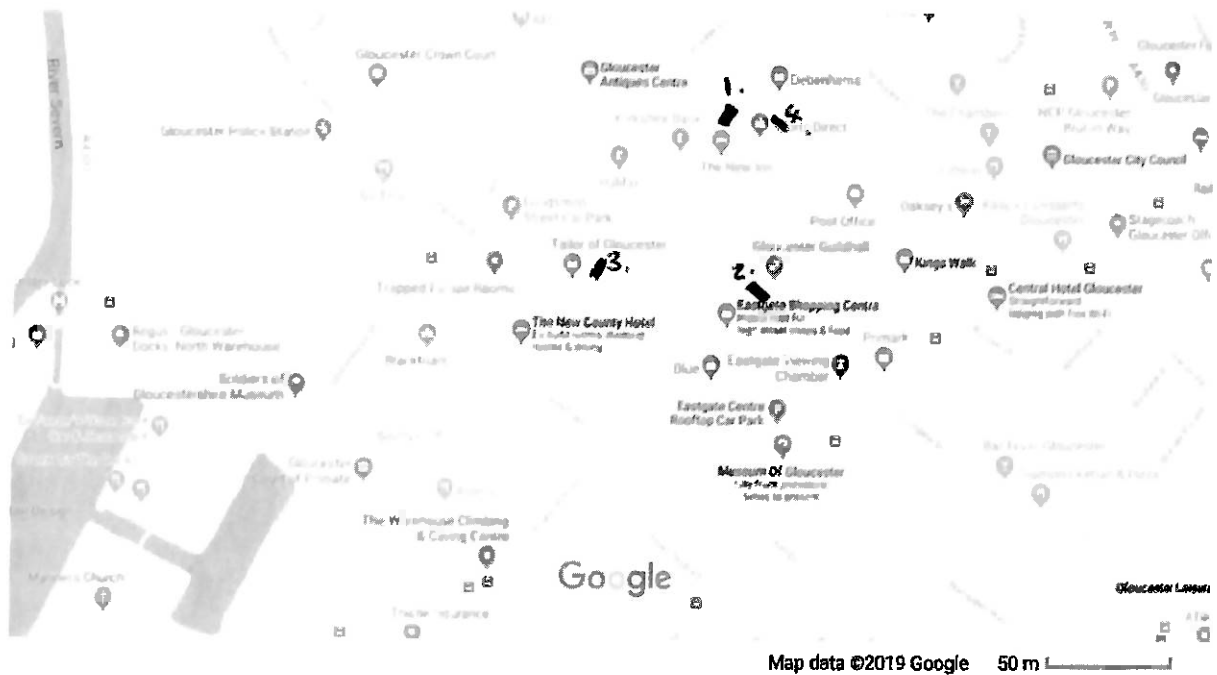

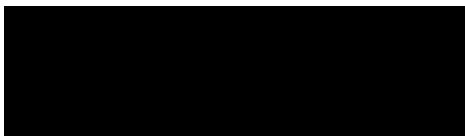
